ORDINANCE NO. 11-017

AN ORDINANCE MODIFYING AND AMENDING
CHAPTER 26 OF THE LANSING MUNICIPAL CODE
AND CREATION OF A NEW SECTION 26-118 WHICH
PROHIBITS THE SALE OF SINGLE OR LOOSE CIGARETTES

WHEREAS, there is currently in force in the State of Illinois a statute (720 ILCS 675, et. sq.) the title of which is The Prevention of Tobacco Use by Minors and The Sale and Distribution of Tobacco Products Act, which, at Section 675/1(d) provides as follows:

The sale or distribution by any person of a tobacco product in this Section, including but not limited to a single or loose cigarette, that is not contained within a sealed container, pack, or package as provided by the manufacturer, which container, pack or package bears the health warning required by federal law, is prohibited.

WHEREAS, the Lansing Police Department has expressed a concern regarding an escalation of such use and a desire to prohibit such conduct by local ordinance as well as the aforesaid statute; and

WHEREAS, the President and Board of Trustees of the Village of Lansing concur in the recommendation of the Lansing Police Department and have concluded that the best interests of the Village of Lansing would be served by the enactment of a local ordinance prohibiting such conduct.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Lansing, Cook County, Illinois, in the exercise of its Home Rule powers as follows:

Section 1: That Chapter 26, entitled "Offenses and Miscellaneous Provisions" of the Lansing Municipal Code is hereby modified and amended by the inclusion and addition of a new section, described as Section 26-118, entitled, "Sale of Single or Loose Cigarettes Prohibited", which section shall provide as follows:

The sale or distribution by any person, whether a minor or not, of a tobacco product, as that term is defined by Illinois Statute, including but not limited to a single or loose cigarette, that is not contained within a sealed container, pack, or package as provided by the manufacturer, which container, pack or package bears the health warning required by federal law, is prohibited.

Section 2: All ordinances, or parts of ordinances in conflict with this ordinance be and the same are hereby repealed to the extent of such conflict.

Section 3: This Ordinance shall be in full force and effect from and after the date of its passage, approval and publication as provided by law.
